From NEK Legislative Update to ACT Ski Tour

NEK Chamber to hold 2nd Legislative Update

The Northeast Kingdom Chamber of Commerce will hold its second legislative update of the year, by Zoom, on Monday, Feb. 28, from 8 to 9 a.m. The program starts with a short update from the chamber, continues with legislator reports addressing key issues and concludes with a question-and-answer period at the end of the event.

Expected issues to be discussed include Covid-19 and its impact, health care, labor and economic development issues, taxes and fiscal policies, not to mention the many issues that arise during the session. Laural Ruggles will serve as co-host of the online meeting along with NEK Chamber Director Darcie McCann.

'The chamber will continue to hold these updates online until the Covid numbers go down apprecia-

bly," said McCann. "This format allows constituents to receive updates from legislators until we believe it is safe to meet in person again."

McCann noted that the format of the gatherings will remain the same, despite the online component of the forum, including the question-and-answer period.

"The January forum went extremely well and we will continue that format going forward for the foreseeable future," she said, noting questions from constituents will be taken in the comment section of Zoom. To receive a link to the online forum, the chamber suggests checking out the chamber's Facebook page, Northeast Kingdom Vermont Chamber of Commerce, where the Zoom link will be pinned to the top of the page for easy access. People may also contact the chamber at director@nekchamber.com to get the link.

The forums are held the last Monday of each month from January to May, from 8 to 9 a.m. Please mark your calendars for the remaining 2022 dates of March 28, April 25 and May 23. The forums will be recorded, with video links provided on the chamber Facebook page following the event.

Hungry Bear Pub & Grill

We probably all are hoping that the end of the COVID-19 pandemic is near. Of course even that may be debatable. I mention this just to say that while some are still wearing a mask when going out to dine, others are not. The bottom line is that "going out to eat" is, I hope, becoming an enjoyable and fun thing to do once again.

Janice and I did just that for a Saturday lunch time. We left home a bit before noon in order to do a couple of quick Saturday chores and then headed south on Route 5. There was a bit more snow than we had expected, but Janice drove safely and we made it without any incident.

We did wear our masks as we entered the front door and were quickly invited to "sit wherever you would like"

by one of the waitstaff members. So we went out to the back room area, picked one of the low tables, took off our coats, sat down and removed our masks. The waitress soon came out with three menus in plastic. One was the day's specials, plus one regular menu for each of us.

Our waitress was quite busy with the lunch crowd. Janice asked for a simple glass of water while I asked for a list of "on tap" beers. The Hungry Bear has a good range of such beverages and I settled on a Sam Adams.

Next was the decision making for the meal itself. Janice decided to go with a favorite, the fish and chips with fries. Meanwhile one of the specials hit my ear and I decided, once again, to try something I had never had.

In fact I don't remember ever seeing it listed anywhere. It was listed as a Corned beef and bacon melt. The description said "thin sliced corned beef, bacon, cheddar cheese and honey mustard on butter grilled whole wheat served with a side of hand cut fries." I did ask, and was granted, the option to turn the fries into onion straws. For those not aware of onion straws they are very thin onion rings.

With the meal ordered we could sit back and do some people watching, or take a look up at one of the TV's that are placed all around the eating and bar area.

When our meals came out neither of us were disappointed. Janice's fish and chips included a large pieces of fish coated with panko and fried to a perfect crisp plus a cup of coleslaw

and plenty of those hand cut fries. One of the first things she did was to trade some of her fries for some of my onion straws. I saw it as a fair trade.



My sandwich was nicely toasted and very thick. There was no skimping on either the corned beef or the bacon. I got a good taste of each with every bite.

Another great thing about local eateries is that there alwavs seems to be some sort of conversation going on between those seated at the same table, or especially with someone walking by. Part of my enjoyment comes from overhearing some of those conversations. (This day's captured conversation included news about sugar making ... the sweet season will start soon!)

When we finished our meals our waitress stopped in again to ask if we wanted the tab. I wasn't quite done eating during this meal time so I asked what was available for deserts. She informed me that they had cheesecake topped with strawberries or a molten lava cake. I thought and decided on the cheesecake.

"Would you like strawberries with that?

"Yes, please!"

So she soon returned with two forks and one nice sized piece of cheesecake and plenty of strawberry slices, and even a dab of whipped cream. I do believe it worked just fine.



When all was said and done our total came to \$46.93. I put my credit card on the bill and our waitress took it out back to run the card through. As usual Janice left a cash tip on the table underneath the credit card slip.

Why think about finances? In April we have our annual tribute to the government, also known as income taxes, as we are already in the process of reviewing our finances, let us take an extra step and get our will in order. Even a simple will, stating all of your assets go to your spouse or your only living relative, is important to protect what happens to your property. Check with your state, people who die without a will, may cause their family to have a long probate period before family receive anything from the loved one.

I know of a woman who, due to COVID-19, was having an extended stay in a skilled nursing home. Her financials were handled thru the facility's accounting department and when she died, without a will, the facility kept the extra money in her account. Eventually they turned it over to the State but the accumulation of dollars from the COVID Stimulas Plan may have been a kindness to her family. There was no will because she didn't have anything more than her Social Security, but the unexpected Government aid had left her with several thousand dollars. That is now claimed by the State.

I know of another person who died without a will, their property is in probate, it has been years. The house is sitting unused with everything the same as the day they died. Nothing touched or removed, rotting food in the refrigerator, decaying vehicle in the garage, weather ruining the exterior of the house, a true ghost house due to the lack of a will. What does it matter to person who has passed? We will never know.

"The most common type of will is called a testamentary will. It is a legally enforceable document stating how you want your affairs handled and assets distributed after you die. It can also include a directive of how you want your funeral or memorial held. A will is an important component of estate planning, and a number of online will makers offer tools for generating legal forms and documents. Experts suggest seeking legal counsel from an attorney that can take into account your individual estate-planning needs." per Investopedia.com, Will vs. Trust: What's the difference? Selecting and paying for a burial spot is one less thing for grief stricken relatives. Talking with your local mortician about preselecting what your funeral will look like and purchasing a funeral package is a good idea. It can be very costly to deal with a funeral, having that expense taken care of will be a kindness to those left behind. I recommend making a call and taking the time to talk about options.

Grim thought but there are only two things guaranteed in life, death and taxes. Let us all take a moment to review our assets and how we are leaving our loved ones. My point is that we should take the time to make sure we are not leaving anything to chance.

Letter to the Editor: Misinformation?

To the Editor,

With budget season upon us, it seems appropriate to address statements made by the Haverhill Town manager in the Jan 6th edition of the Journal Opinion. In her self-congratulatory letter, she proclaims among other things that she saved about \$274K by combining Haverhill's fire departments.

Not so fast. If you look at the Town budget you will see that she eliminated over 80K from the fire budget by paying the truck and air pack loans and insurance costs elsewhere. I hope she didn't injure her arm patting herself on the back for that. Spoiler alert, these items have been or are still being paid for by us even if they don't show up under the fire heading.

Then there is one of her favorite pastimes of fighting against the Woodsville part of Town. This time the TM was able to cheat them out of their entire fire department funding. That "saved" another 140K. Even better, having control over the checkbook and taxes gave her the ability to still tax Woodsville folks for her "Haverhill Fire Department" and make them raise the money for their own department all over again!

Bottom line, if you look for actual savings, you are looking at far less than claimed and a good deal of that is likely due to a reduced utilization of the fire services versus anything that she has done.

Spend smarter were some of her buzzwords. That's a good point. She's smart enough to have gotten the admin costs up from \$170k/year in 2020 to about \$300K/year now.

Here's an interesting and related tidbit. Haverhill's 2019 audit was reportedly

Town Budgets can be hard to read say nothing about understanding unless you really take the time to do so. Then there is the question about the interpretation of those numbers. I urge every voter to take time to at least look at the annual town report, whether it is in Haverhill or elsewhere, and try to understand what is being done with your tax dollars. After all it is your money being spent. And as a voter you

finished about a month or so ago. It is well over a year late. Don't dare ask why. It's now 2022 and the completed audit results do not seem to be available vet. Could it be possible that they will appear after elections?

As long as I'm writing anyway, it seems like an opportunity to expose another contradiction. In early December, our kindhearted Town manager's letter about the importance of human interactions was published. She begins with "We have systematically seen the denigration of human interaction...". She suggests that we limit the time spent on Social Media, that we hug someone, offer smiles, etc. All great ideas that I fully agree with.

Along with this letter I send today, I include a screen shot of an interaction just before her "better human interaction" letter to the editor was sent. It is the Town Manager's interaction with a citizen of our town in which she uses the "F" word and rants on this citizen mercilessly. What did he do to deserve this berating? He had the audacity to push back on her move to close airport road on which his family resides.

The TM fully knows that at the 2015 annual Town meeting, we addressed closing Airport Road for the very same safety related reasons. It was even proposed by the same engineering firm that we use today. The vote was 10 for closing airport road vs 122 to leave it open. Remember when the wishes of the citizens meant something? Remember back then when we had so few people at Town meeting? That was before TM Codling and Selectboard members Clogston and Bjelabrk came along to get us all fired up. At least attendance is better now.

Misinformation seems prevalent from this TM. Is it just an inability to get things right or is it deliberate? It could very well be either

Consider our tax bills that are to be in our hands around November 1st and due to be paid in early December. In her first year here, they were sent on December 21. Second year on Dec 6th and this time on January 7th.




Carolyn Moss: OBITUARY

My next column will tell about a couple of trips we took in the car as well as doing housekeeping duties in La Torre.





Historical Society Celebrates a 'Forgotten' Milestone

The Waterford Historical Society kicks off its 2022 season Wednesday, Feb. 23, at 4:30 p.m. at the Davies Memorial Library in Lower Waterford with a special decree.

The renaming of Waterford from Littleton 225 years ago will be acknowledged as part of a history-and-heritage proclamation by Vermont Gov. Phil Scott scheduled to be read by state Representative and resident Marcia Martel. The name change finally put an end to a hold-over from when the British provinces of New York and New Hampshire competed to own Vermont lands, and gave grants to speculators for settlement.

The public is invited, including Waterford descendants living in the area. A special anniversary cake will be served and the 2002 hardbound edition of "A Vermont Village" by Dr. C.E. Harris that includes an index will be available. A brief business meeting by paid members to elect two officers follows the reception.

The historical society's 2022 program calendar will also be distributed for the first time. In addition to monthly gatherings through October, the directors have planned unique anniversary programs with community partners to share town history at five different locations:

April 30, Saturday, 2-4 p.m. with Davies Library Trustees: Waterford Speaks: Writers of History Share Their Stories including two authors, Beth Kanell and Helen Pike, who will talk about their adventures.

New Pleasures in History & Society Executive Director Steve Perkins. The Rhubarb Kitchen will be open.

Watch for changes when filing taxes

before the April 18 filing deadline, you'll want to be up to date on changes that could affect you. Here are some issues to discuss with your tax professional:

 COVID-19-related distributions and recontributions - If you took a coronavirus-related distribution (withdrawal) from a retirement account, such as a 401(k) or IRA, in 2020 and chose to spread the amount equally over three years, you need to include the relevant part of the distribution on your 2021 tax return, so you should bring your 2020 Form 1099-R to your tax advisor. You can recontribute your distributions back into any retirement account eligible to receive a rollover for up to three years after you received the initial distribution. So, if you haven't already done so, you can still recontribute to your 401(k) or IRA up until the April 18 filing deadline - and by doing so, you could reduce your 2021 taxes.

> (Your tax professional will know what forms and documentation you'll need for this recontribution.)

> Return of RMDs – In 2020, the Coronavirus Aid, Relief and Economic Security (CARES) Act suspended required minimum distributions (RMDs)

As you prepare your tax returns from retirement accounts that people over a certain age typically must take. But RMDs returned for 2021 and had to be taken by Dec. 31, unless your birthdate is between July 1 and Dec. 31, 1949, in review your IRA contributions. which case your starting date was delayed until April 1, 2022. So, if you had an RMD for 2021, bring your 2020 Form 5498 or your 2021 retirement account statements to your tax professional to calculate the required RMD. You'll also want to provide your 2021 Form 1099-R to report the amount of RMDs taken.

- Charitable contributions The CARES Act authorized a deduction for cash contributions to qualified charities for those who don't itemize. For 2020, the maximum deduction was \$300; this provision has been extended for the 2021 tax year, with a new provision allowing a \$600 deduction for joint filers. If vou do itemize deductions, be aware that the CARES Act also suspended the 60% of adjusted gross income limit for cash gifts in 2020, a change that has been carried over to 2021.
- Child tax credit For 2021, you can claim up to \$3,600 for children younger than 6 and up to \$3,000 for children ages 6 to 17. This tax credit is refundable, which means you can receive it even if it's larger than the amount of taxes you owe. The credit phases out at certain income limits.
- Child and dependent care credit - This credit is more substantial in 2021 - up to \$4,000 for one qualifying person and up to \$8,000 for two or more. This credit is also potentially refundable, but it phases

out differently than in previous years, so you'll want to go over your dependent-care expenses carefully with your tax professional.

And last, but certainly not least, There aren't any changes for 2022, but you can still fund your traditional or Roth IRA for the 2021 tax year up until the April 18 deadline.

See your tax professional soon to ensure you've got everything in order. Staffing shortages at the Internal Revenue Service (IRS), combined with a heavy workload due to pandemic-related programs, may slow down processing of returns, so consider getting your taxes done as soon as possible especially if you're anticipating a refund.





David Robinson - 3 Year Term

1. What is your top priority as a member of the School Board?

My priority is the kids. I have two daughters just starting in the schools. We cannot succeed



in the future without supporting our children to develop into adulthood. We will have many complex things to deal with as a board. Our community is splintered in a lot of ways but one thing we all have in common is our love for our children and family. I will listen to each side of the discussion when it comes to issues like school infrastructure, curriculum, social/ emotional support and many more.

2. What is your position on the future of Woodsville Elementary School?

I don't have a position at this point. There are two complex things at play: finances and culture. We need to listen to taxpayers and find a long term fiscally responsible way to address the building issues at WES. We need to compare estimates from engineers. We need to discuss with our finance and administrative employees the economies of scale savings potentials. We also need to talk to teachers and administrators about the school culture and educational needs.

3. What, if any, new program would you like to see started in Haverhill?

I would like to see us pursue new ways to improve math and reading levels at the lower grades. I understand that some of this has begun at the elementary school, and I would like to see us continue to expand upon that. I would also like to see us build better communication between parents and teachers. Right now, it seems like there are a lot of different means of communication and online participation options for parents. I want us to consolidate and simplify that process. Parents are very important in helping their children develop. Good communication will allow parents to be better informed about their child's education, and teachers can better serve the child if they understand all parental concerns.

4. How should the School Board interact with the Select Board?

I don't believe a formal process needs to be established. I would encourage board members from each board to attend some meetings of the other board on their own accord. Any public servant should be informed about the community they serve. This involvement can help to facilitate growth as a board member.

5. Why should the voters of Haverhill elect you as a member of the School Roard?

I believe in our community. We have a lot of division in our town right now. I have been vocal on some issues that I believed in passionately. I believe it is the responsibility of a board member to put their personal feelings on a matter in a neutral place until all sides have been heard. I will put myself in the shoes of the person I disagree with. I think we need to do that more. It may not change our opinion or stance on a matter; however, it may allow us to start to have a respectful discussion.

Michael Thompson - 3 Year Term

1. What is your top priority as a member of the School Board?

My top priority as a HCSD school board member is the same as my top



the same as my top priority as a teacher: To do everything in my power to help our learners be safe, engaged, and successful while taking their Social and Emotional needs into account in addition to their academic needs.

2. What is your position on the future of Woodsville Elementary School?

I don't have enough information yet for a fully formed position. I don't know what concerns there are about WES, what the effect they have on our learners, what solutions for those concerns are available, or what it would cost to remediate those concerns if necessary. I know that the team at WES is dedicated, caring, and professional, I know that our community supports the health, safety, and success of our youngest students and that as part of the HCSD board I'll be in a position to find answers, gather input from the community, and collaborate with all stakeholders to come up with a recommendation that is in line with our community culture and values.

3. What, if any, new program would you like to see started in Haverhill?

One of my areas of postgraduate research has been developing funding models outside of tax revenue to enhance the Social and Emotional well being of students. As a member of the HCSD board I would work with the school leadership team to find ways to improve our existing programs while reducing the tax burden on Haverhill homeowners.

4. How should the School Board interact with the Select Board?

I think that both boards should have an ongoing dialog about matters that affect us all. We should certainly stay focused on the important work each board has to do, but I think that the perspective of the Haverhill Selectboard is incredibly useful for the HCSD School Board and vice versa. In fact, I would say that overall diversity of perspective leads to better decision making on all fronts.

5. Why should the voters of Haverhill elect you as a member of the School Board?

I've lived in Haverhill most of my life. attended Haverhill schools. worked in our schools, and am about to complete an advanced degree in school leadership. I have the experience, education, and perspective on the culture of our community that none of the other candidates have. I would like to see more data gathered on educators and staff leaving the district. While some moves are unavoidable and perhaps caused externally, we need to find ways to keep the best talent that we have in-district, especially after our investments in them. I would also like to explore more alternative revenue sources to reduce taxpayer burden and possibly expand the afterschool program to include early morning/before school activities.

4. How should the School Board interact with the Select Board?

I believe that while the two boards should remain separate and autonomous, we should have requcommunication, particularly when it comes to topics of common interest. For instance, in December Senator Guida briefed the Select Board on a recent bill that will provide extra money to school districts, as well as his sponsorship of a bill to establish "extraordinary need school districts." No Haverhill board members were present for this meeting, though this is obviously an area where discussion and input would have been valuable for both parties.


5. Why should the voters of Haverhill elect you as a member of the School Board?


5. Why should the voters of Haverhill elect you as a member of the School Board?

For example culvert work in Mountain Lakes or fixing an intersection issue on Forest Street, communication is important. As far as the school board, these are entities with specific purposes and we should each stay within our respective lanes, but with that being said it is always a good idea to be informed of what each entity is doing.

5. Why should the voters of Haverhill elect you as a member of the Select Board?

Portuguese Soup

Hello hello my fellow chefs. How are you all doing today? I'm having trouble with my clogged drain. Three different plumbers came and it seems I need my system cleaned. Now my friend Mike is digging to try to find the cover. We are not having good luck. The next step is to get someone with a backhoe. I am getting frustrated because I'm supposed to leave for Rhode Island in a few days and I don't like leaving my house with this problem. Oh well that's my current problem. It's always something, if it's not one thing it's another, right?

Let's get started with today's recipe and how to make it. This is how I was taught how to make it from my husband's Portuguese grandmother. So this is "VoVo's" recipe.

Ingredients

- 3 Tbsp olive oil
- 3 medium Yukon gold potatoes peeled and cut into bite size pieces
- 2 medium onions chopped small
- 4 fresh garlic cloves chopped small
 - 2 bay leaves
 - 1 bunch kale or 1 lb.
- 1 tsp Lawry's seasoned salt
 - 1/2 tsp black pepper 1 15oz. Can cannellini
- beans rinsed 1 14/15oz.can diced tomatoes
- 1 lb. Gaspar Chourico sausage (find near hot

dogs) remove casing

1 quart (32 oz) plus 1 cup 8 oz. Chicken broth Warm crusty bread



First take out all the ingredients and put on counter so everything will be ready. Peel and cut potatoes and onions and garlic. Remove casing from Chourico and slice 1/2" circles then cut in 4 so you have triangles. Once you get it started it peels pretty easy. Put olive oil in soup pan with cover and heat over medium heat. Add potatoes and onions and bay leaves and fry for about 5-7 minutes then add garlic and fry another 5 minutes tossing around every couple of minutes. Meanwhile chop kale

by holding a bunch on the bottom and starting at the top slice 1/2-1" cuts then tear in half. You don't want giant pieces of kale when you eat the soup. Cut off a couple of inches off the bottom stems because they are tough. Add to pan, season with seasoned salt and pepper and mix. The greens will wilt quite a bit. Add the beans, chourico and chicken broth, mix and cook to a boil then lower heat to a slow boil for 40 minutes making sure potatoes and any center of the kale stalks are cooked. Stir occasionally. Let sit for 10 minutes and serve.

While your soup is cooking heat some crusty Italian bread. I bought a frozen loaf of Italian garlic bread and it was good. This soup is a good source of many vitamins very hearty and "Delicioso " and not to mention how easy peasy it is. It's something different and I hope you try it. If you never had Chourico you are in for a
